**EDUCATIONAL.** Providing trusted, unbiased information about Restless Legs Syndrome [also known as Willis-Ekbom Disease] to individuals and healthcare providers through publications, webinars, a website, social media sites, and direct communications. Publications include: a general informational brochure on RLS; a pediatric RLS guide for teens; twenty-four different handouts on RLS-specific topics directed towards patients; a quarterly magazine; monthly E-newsletters; ten specialty brochures directed to healthcare providers; and a medical updates bulletin issued as developments merit. **MEMBERSHIP.** RLSF serves as a support structure for over 20,000 individuals who are interested in RLS as one who suffers from the disease, a person who has a friend or loved one who suffers from the disease, or who is a health care professional providing services to those who suffer the pain of RLS. RLSF provides clearing-house services to its members by publicizing the latest developments in treatment and providing point-of-contact information for persons seeking counseling, treatment, or conversation with others sharing the affliction. Member benefits include access to a proprietary database for treatment information, a quarterly newsmagazine, a subscription to a medical bulletin for health-care providers, a medical-alert card, and access the members-only section of the RLS website.
